

CONDITIONS OF REGISTRATION

General contractual conditions for the providing of internet services

("the GCC") of the company DREVARI.SK, s.r.o. ("the provider"), located at Arm. Gen. L. Svobodu 4, 080 01 Prešov, IČO: 36 501 310, listed in the Trade Register of the District Court of Prešov in the department: Sro, listing number: 15769/P, published according to § 273 of the Trade Law in conformity with law number 610/2003 Z.z. about electronic communications.

- The GCC arranges binding legal relations between the provider and another party (the "client") following from the contract for the provision of internet services ("contracts") and are an inseparable part of the contract.
- The offer of internet services publicized on the provider's internet web pages: www.byvaj.sk, www.drevari.sk and other language versions ("the DREVARI.SK system of portals") is offered upon the closing of a contract.
- A client order for the offer of the internet services of the provider is made by agreement with acceptance of the proposed conditions on the closing of a contract. The order may be in written or electronic form. Electronic form is understood to mean the electronic sending to the provider of a filled-out form from the internet pages of the provider.
- The extent of the provided services is according to the order of the client and in agreement with the offer of internet services of the provider. The offer of the provider is published on the provider's internet pages.
- The price of the provided services is a component of the offer of the provider's internet services and is applicable at the closing of the contract. If in the provider's offer of internet services the price is not introduced, payment for the provided internet services is applicable for the period of one year.
- Rights and duties of the contracted parties.
 - The provider is authorized:
 - to make public the contact information of the registered client within the scope of the prepaid user program and to offer this information to third parties,
 - to cancel or refuse the registration of a client, if:
 - the activities of the firm are not related to the wood or furniture theme of the portal,
 - if the client does not pay the proper registration fee, or if the fee is not paid on time,
 - if the client improperly introduces or presents information about itself or its services, such as in an advertisement, the presentation of product, or in commercial articles,
 - if the client misuses information from the database of the DREVARI.SK system of portals, distributes them further or provides them to a third person for financial gain,
 - to utilize information which the client provided during the registration process for purposes of the provider. The client agrees with the provision of this information to a

- third party,
 - to refuse responsibility for relations towards any offers, information, ordering services or product which will be realized in the environment of the DREVARI.SK system of portals,
 - to refuse responsibility for the continuous, error-free functionality of the system and technical operations and full protection of the DREVARI.SK system of information portals in the case of system crashes or attacks and for damage which would arise to the client as a result,
 - to refuse to make public client information which does not conform to article 6.4. of the GCC,
 - to send out "E-WOOD Newsletter" (namely, collective informational e-mails with commercial contents, business offers, demands and announcements) to the e-mail boxes that the client presented during registration as the E-MAIL FOR BUSINESS CORRESPONDENCE. The client will not consider such activities as un-requested electronic mail from the providing parties (so-called "spam").
 - to refuse the refunding of a paid registration fee for the premature cancellation of a client registration,
 - to opt out of the contract if the client does not pay the registration fee within 30 days of registering.
- 6.2. The provider is obliged upon registration and following the payment of the registration fee to provide the client with the following services:
- for the basic user program on the DREVARI.SK portal:
 - a basic presentation of the client in the DATABASE OF FIRMS in the scope of basic contact information and a brief description of the client's activities,
 - access to published advertisements and their subsequent publication in E-WOOD Newsletter,
 - for the expanded user program of the DREVARI.SK portal:
 - a wider presentation of the client in the DATABASE OF FIRMS in the scope of – contact data of the client, activities of the client, presentation of products and services,
 - advantageous placement of the client card in the DATABASE OF FIRMS,
 - prístup k uverejňovaniu inzerátov a ich nasledovné uverejnenie v DREVÁRSKEJ POŠTE určenej pre slovenských zákazníkov, access to published advertisement and their subsequent publication in E-WOOD Newsletter designated specifically for Slovak clients,
 - access to published special sales offers,
 - the possibility of presenting a maximum of 4 products and services at one time in the CATALOG OF PRODUCTS,
 - translation by the provider of selected advertisements and special sales offers of the client into English and Spanish and their publication on those language versions of the portal,
 - on the request of the client, the creation of an e-mail address in the form "nameoffirm@drevari.sk" with access via WEBMAIL,
 - for the premium user program on the DREVARI.SK portal:
 - a wider presentation of the client in the DATABASE OF FIRMS in the scope – contact information of the client, activities of the client, presentation of products and services,
 - preferential placement of the client card in the DATABASE OF FIRMS,
 - access to published advertisements and their subsequent publication in E-WOOD Newsletter designated specifically for

- Slovak clients,
 - access to published special sales offers,
 - the possibility of presenting an unlimited number of products and services at one time in the CATALOG OF PRODUCTS,
 - translation by the provider of selected advertisements and special sales offers of the client into English and Spanish and their publication on those language versions of the portal,
 - on the request of the client, the creation of an e-mail address in the form "nameoffirm@drevari.sk" with access via WEBMAIL,
 - to publish articles supplied by the client that have commercial contents connected to the wood industry theme of the portal, d.) for the portal partner program on the DREVARI.SK portal:
 - a full presentation of the client in the DATABASE OF FIRMS in the scope of - contact data of the client, activities of the client, presentation of products and services,
 - preferential placement of the client card in the DATABASE OF FIRMS,
 - access to published advertisement and their subsequent publication in E-WOOD Newsletter,
 - the connection of a client logo in each message sent in E-WOOD Newsletter designated for Slovak clients,
 - access to published special sales offers,
 - the possibility of presenting an unlimited number of products and services at one time in the CATALOG OF PRODUCTS,
 - translation by the provider of selected advertisements and special sales offers of the client into English and Spanish and their publication on those language versions of the portal,
 - on the request of the client, the creation of an e-mail address in the form "nameoffirm@drevari.sk" with access via WEBMAIL,
 - to publish advertising articles supplied by the client that have commercial contents connected to the wood industry theme of the portal,
 - to publish on the DREVARI.SK portals (not in other language versions) one advertising banner supplied by the client (size of the banners: 120 x 60 px) free of charge for a 3 month period,
 - to publish the client logo on the introductory page of the DREVARI.SK portal (not in other language versions) in the section titled PARTNERS with a re-route directly to the client's own web page.
- 6.3. The client is authorized:
- to cancel registration prematurely in the DREVARI.SK system of portals. Premature cancellation of registration must be provided by the client in written form. By premature cancellation of registration the client forfeits the right to be refunded the proportionate part of the paid registration fee (the price of the provided service),
 - to cancel in writing the sending of E-WOOD Newsletter,
 - to request help for utilizing the provided services: for registration of firms, for the publication of presentations of goods and services,
 - to have access to information about the number of visitors to the DREVARI.SK system of portals (in particular: www.byvaj.sk, www.drevari.sk, www.drevari.cz, www.e-wood.biz, www.e-madera.com)
- 6.4. The client is required:
- to pay the registration fee properly and on time according to the applicable price for the ordered user program,
 - to provide accurate information during registration and for utilization of the

- DREVARI.SK system of portals. The provider assumes no responsibility for the contents of the information presented by the user. The client must be fully aware that any information provided or obtained in the service environment of the DREVARI.SK system of portals are not verified by the provider and working with such information is therefore the personal decision, responsibility and risk of the client.
- to provide supplemental information about the client, the client's offers or demands, or about the client's products in electronic form, which would be friendly for the DREVARI.SK system of portals, namely:
 - for a picture in the format: jpg, gif, png, tiff, eps differentiated a minimum of 72 dpi, maximum size of 250 kB/picture,
 - pri vektorových obrázkoch vo formáte: cdr, ai, eps, veľkosť max. 250 kB/obrázokfor vectorial pictures in the format: cdr, ai, eps, a maximum size of 250kB/picture,
 - for text materials: doc, pdf, txt, rtf, xls, a maximum size of 250kB/file,
 - to present during registration at least one e-mail contact. If this is not done, the provider is not responsible for the obligation to provide access of the client to E-WOOD Newsletter sent to the incorrect address. If an item designated as E-MAIL FOR BUSINESS CORRESPONDENCE is not filled in by the client, E-WOOD Newsletter will be sent to the address used in the E-MAIL pane.
7. Changes and additions to the contract are possible only in written form and with the agreement between the provider and the client.
8. The provider is obliged to secure protection of personal data in agreement with law number 428/2002 Z.z. regarding the protection of personal information.
9. The provider and the client are committed to solving cases of conflict by agreement, respectively by the mediation of the courts of the Slovak Republic.
10. The provider and the client agreed their relations are in compliance with the Trade Law and other general binding legal statutes of Slovakia.
11. The provider and the client in special cases may arrange contractual conditions by written contract. By such a written contract they may agree also to contractual conditions differing from the GCC.
12. The provider may change the GCC unilaterally and these changes go into effect on the day following the initial publication of the change on the internet pages of the provider.
13. The GCC becomes valid and effective on 15 February, 2005
